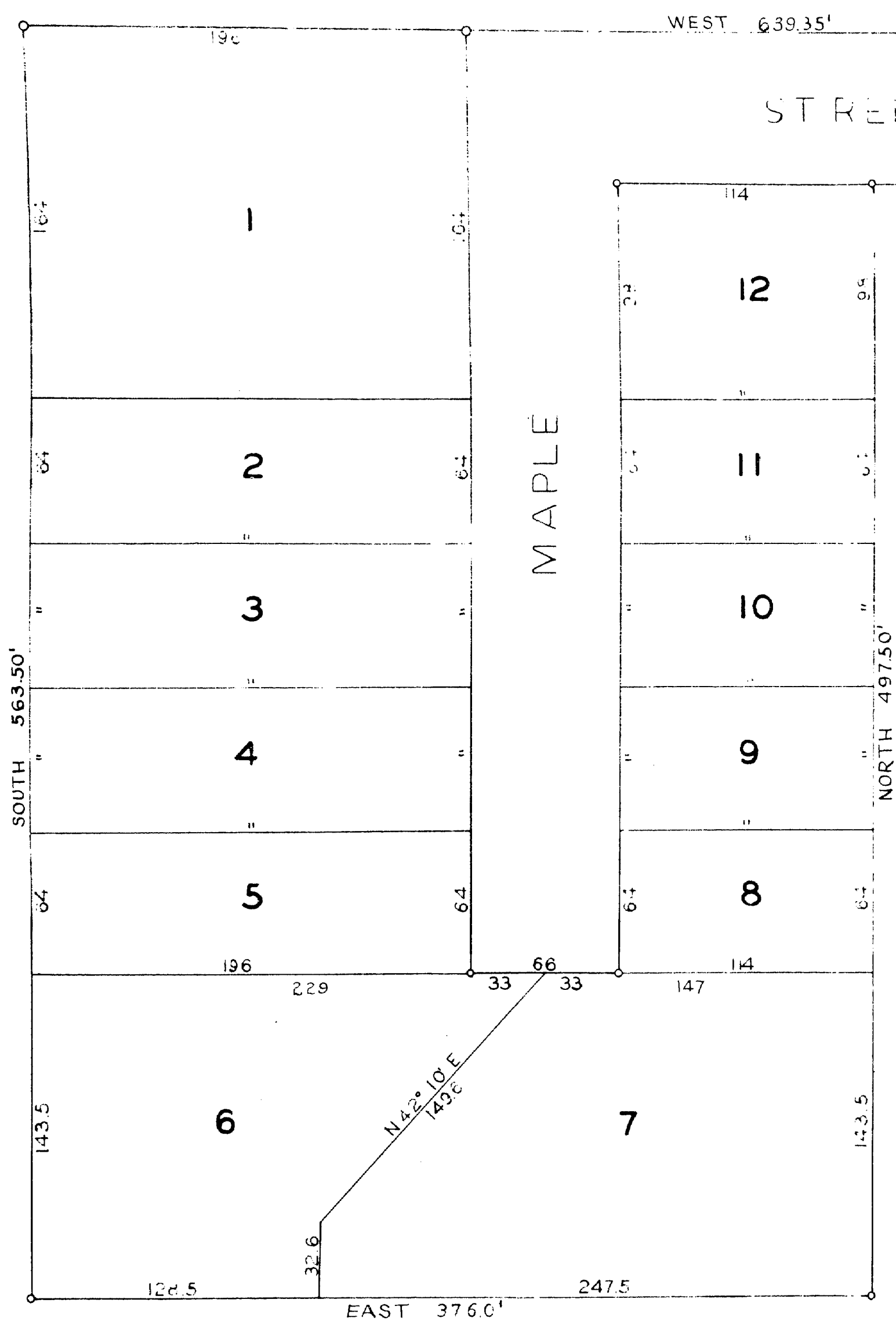
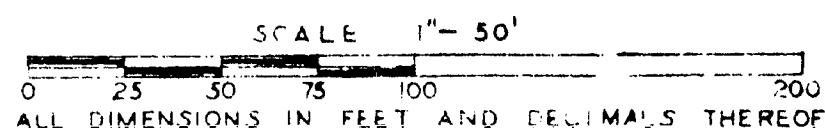


# MAPLE GROVE SUBDIVISION
