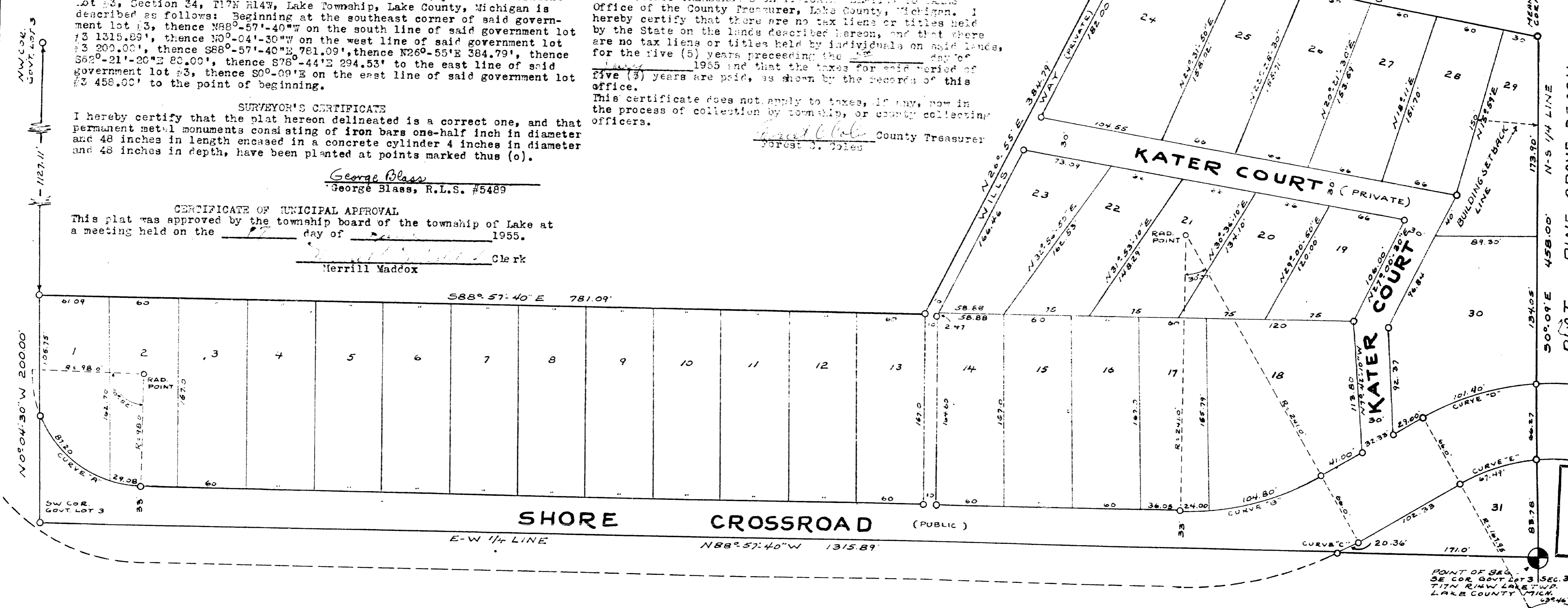
COUNTY TREASURER'S CERTIFICATE RELATIVE TO TAXES
