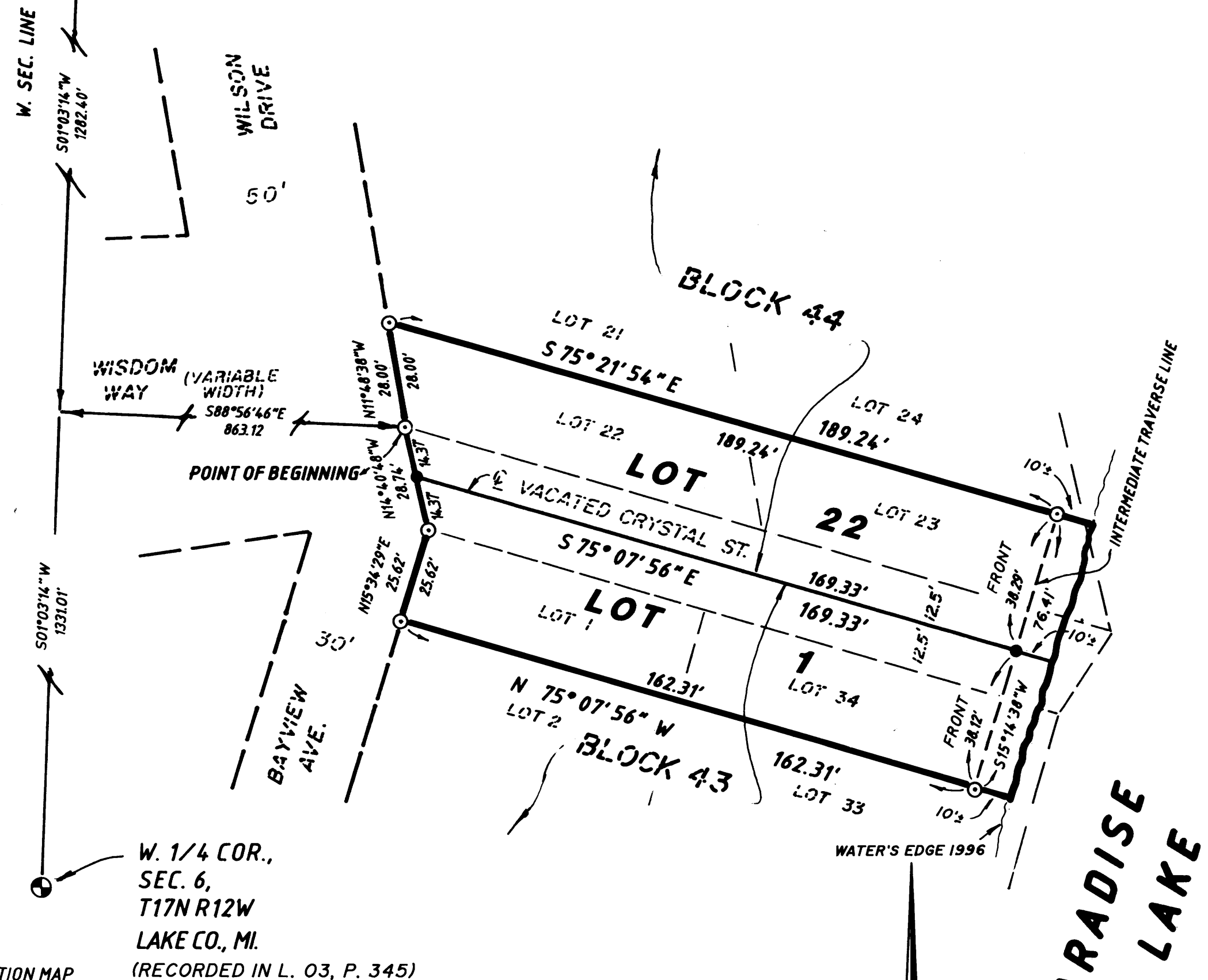

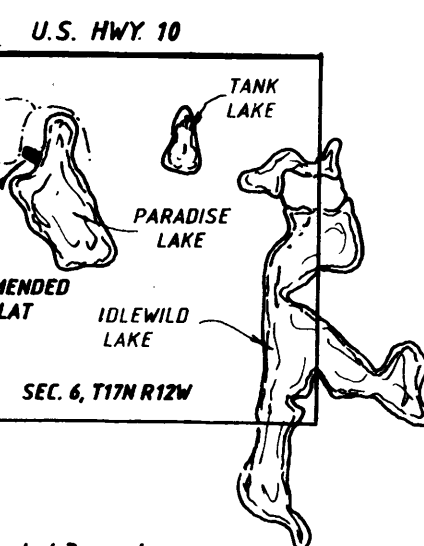

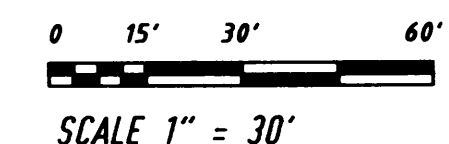
MONUMENTS CONSISTING OF 1/2" DIAMETER STEEL RODS 36" IN
