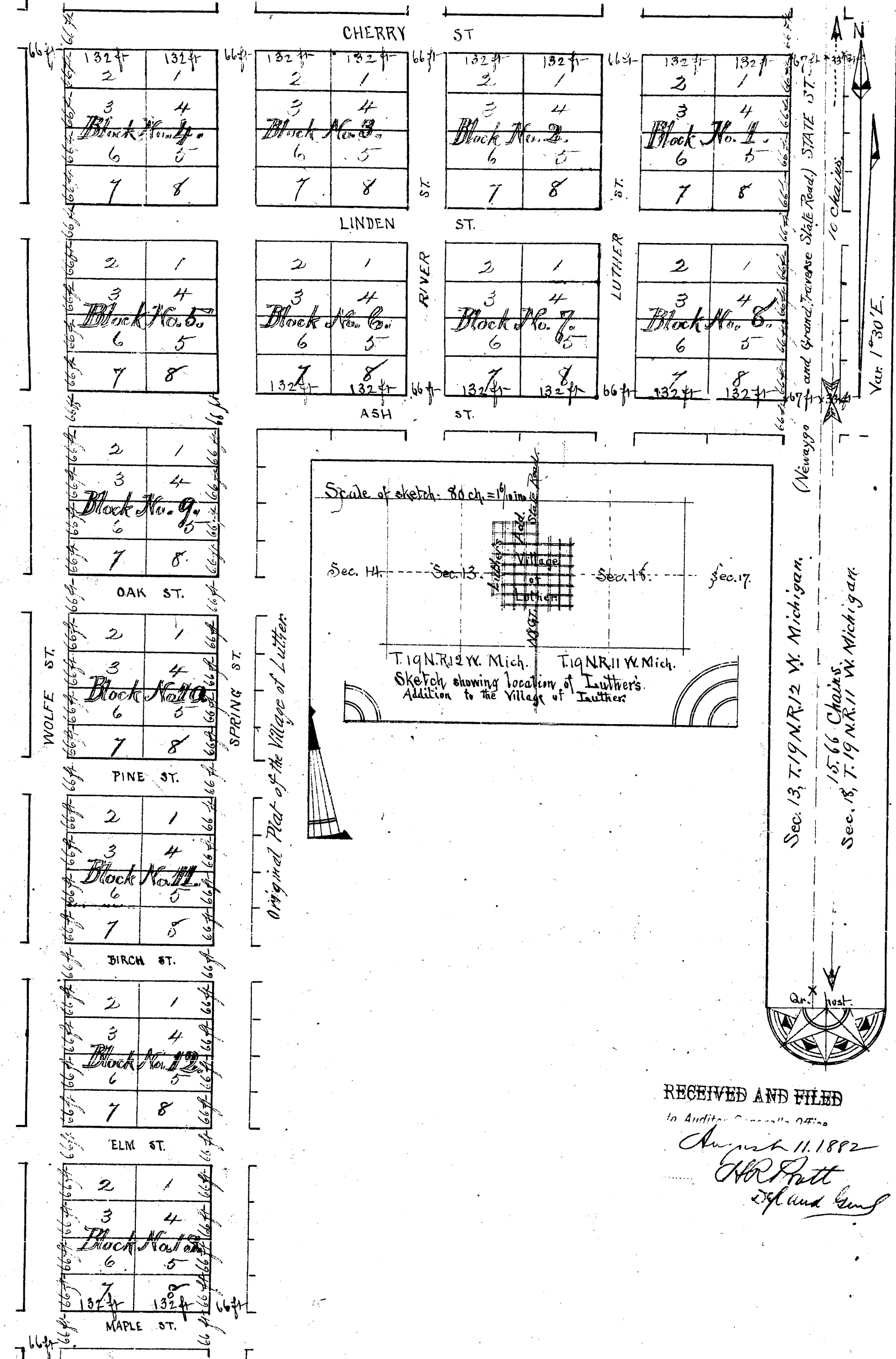


MAP OF LUTHERS ADDITION TO THE VILLAGE OF LUTHER,

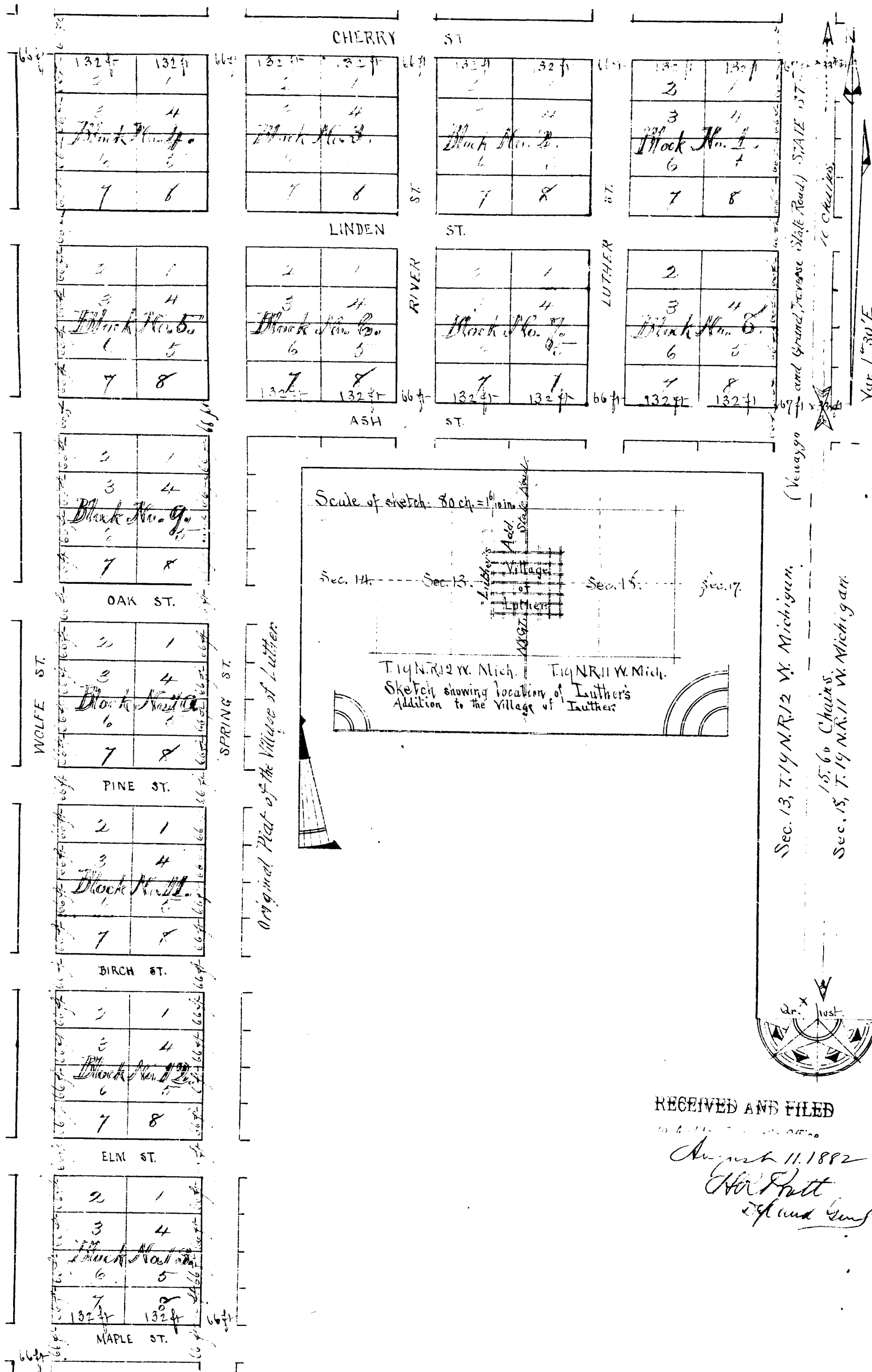
