Commissioner Raymond made a motion to approve the amended FY 2022-2023 County Child Care Budget Summary for the Basic Grant between the Lake County and the Michigan Department of Health and Human Services (MDHHS) and authorize the Board Chairman to sign any and all necessary documents; with a second from Commissioner Welford.
