Commissioner Fuller made a motion to approve of the semi-monthly detail analysis dated May 10, 2023 totaling \$111,486.89; with a second from Commissioner Balulis. Roll call vote: Welford-yes, Sanders-yes, Raymond-yes, Arquette-yes, Fuller-yes, Balulis-yes and Lodholtz-yes. Motion passed.

Commissioner Fuller made a motion to approve of FY-2024 County Veteran Service Fund Grant in the amount of \$60,256 and authorize the Board Chairman to sign any and all necessary documents; with a second from Commissioner Welford. Roll call vote: Sanders-yes, Raymond-yes, Arquette-yes, Fuller-yes, Balulis-yes, Welford-yes and Lodholtz-yes. Motion passed.

Commissioner Fuller made a motion to authorize the Parks Commission Chair to enter into a contract with Dan's Excavating for construction at a cost expected to be \$467,774.50; and to authorize the County Administrator to make certain improvements to the pavilion at the park, including the installation of electric, paint, and structural enhancements, and the purchase of picnic tables, at a total cost not to exceed \$561,294 and make amendments to the budget as necessary; with a second from Commissioner Arquette. Roll call vote: Raymond-yes, Arquette-yes, Fuller-yes, Balulis-yes, Welford-yes, Sanders-yes and Lodholtz-yes. Motion passed.

Commissioner Raymond made a motion to approve of Resolution #2023-12 for the costs, special assessment, and issuance of bonds for the Wolf Lake Level Project; with a second from Commissioner Sanders. Roll call vote: Arquette-yes, Fuller-yes, Balulis-yes, Welford-yes, Raymond-yes, Sanders-yes and Lodholtz-yes. Motion passed.

Commissioner Raymond made a motion to grant an exception to Resolution #10/23/13 1299 (No Out of State Conferences/Training/Meetings) for the Administrator's attendance at the ICMA Conference; with a second from Commissioner Balulis. Roll call vote: Fuller-yes, Balulis-yes, Welford-yes, Sanders-yes, Raymond-yes, Arquette-yes and Lodholtz-yes. Motion passed.

Commissioner Raymond made a motion to approve of the contract with the Rossow Group and the Lake County Sheriffs' Office, including the \$40,000 budget amendment and grant change, and authorize the Sheriff to sign the contract; with a second from Commissioner Arquette. Roll call vote: Balulis-yes, Welford-yes, Sanders-yes, Raymond-yes, Arquette-yes, Fuller-yes and Lodholtz-yes. Motion passed.

Commissioner Raymond made a motion to approve of Resolution #2023-10 recognizing May as Mental Health Awareness Month; with a second from Commissioner Martin. Roll call vote: Welford-yes, Sanders-yes-yes, Raymond-yes, Arquette-yes, Fuller-yes, Balulis-yes and Lodholtz-yes. Motion passed.
