Commissioner Raymond made a motion to approve the third quarter fiscal year 2023 budget amendments as presented in the Quarterly Budget Amendment Report; with a second from Commissioner Arquette. Roll call vote: Arquette-yes, Raymond-yes, Sanders-absent, Welford-yes, Balulis-yes, Fuller-yes and Lodholtz-yes. *Motion carried*.

Commissioner Raymond made a motion to approve authorization of the County Administrator to do FY 2023-year end budget amendments and transfers as needed; with a second from Commissioner Fuller. Roll call vote: Raymond-yes, Sanders-absent, Welford-yes, Balulis-yes, Fuller-yes, Arquette-yes and Lodholtz-yes. *Motion carried*.

Commissioner Raymond made a motion to authorize the County Administrator to approve and pay the FY 2023-year end accounts payables; with a second from Commissioner Welford. Roll call vote: Sandersabsent, Welford-yes, Balulis-yes, Fuller-yes, Arquette-yes, Raymond-yes and Lodholtz-yes. *Motion carried*.

Commissioner Raymond made a motion to approve of the purchase and outfitting of two new Rd Patrol vehicles out of the FY-2024 budget at a cost not to exceed \$152,000.00 (two vehicles \$103,136.00 to be purchased out of 207-901.00-981.000 and \$48,840.80 Outfitting 207-901-00-981-002); with a second from Commissioner Welford. Roll call vote: Welford-yes, Balulis-yes, Fuller-yes, Arquette-yes, Raymond-yes, Sanders-absent, and Lodholtz-yes. *Motion carried*.

Commissioner Raymond made a motion to give the County Clerk a \$2,000 annual pay increase due to additional duties, effective 1/1/2024, in addition to the 5% COLA increase already approved for 2024; with a second from Commissioner Fuller. Roll call vote: Balulis-yes, Fuller-yes, Arquette-yes, Raymond-yes, Sanders-absent, Welford-yes, and Lodholtz-yes. *Motion carried*.

Commissioner Fuller made a motion to approve of the renewal of Blue Care Network (BCN) as the County's Health Insurance for 2024 for both Active Employees and Pre-65 Retirees with active employee cost share as noted, and authorize the Administrator to sign any and all necessary documents; with a second from Commissioner Welford. Roll call vote: Fuller-yes, Arquette-yes, Raymond-yes, Sanders-absent, Welford-yes, Balulis-yes and Lodholtz-yes. *Motion carried*.

Commissioner Fuller made a motion to authorize the County Administrator (contingent upon 44 North & Delta allowing) to enhance the Dental Insurance benefits for elected and non-union employees and switch the cost share arrangement for both Dental & Vision to an 80/20, effective January 1, 2024 and to authorize any needed changes to the personnel manual.; with a second from Commissioner Balulis. Roll call vote: Arquette-yes, Raymond-yes, Sanders-absent, Welford-yes, Balulis-yes, Fuller-yes and Lodholtz-yes. *Motion carried*.

Commissioner Fuller made a motion to Accept and Ratify the Agreement for Election Services between the Lake County Clerk and 15 Lake County Townships; with a second from Commissioner Welford. Roll call vote: Raymond-yes, Sanders-absent, Welford-yes Balulis-yes, Fuller-yes, Arquette-yes and Lodholtz-yes. *Motion carried*.
