Commissioner Arquette made a motion to authorize the purchase of two 2021 Ford Explorer Interceptors at a total cost not to exceed \$75,032.00; and to outfit them by ProCom at a cost not to exceed \$37,983.00; with a second from Commissioner Sanders. Roll call vote: Arquette-yes, Dermyer-yes, Sanders-yes, Todd-yes, Balulis-yes, Martin-yes and Lodholtz-yes. Motion carried.

Purchase request from Lake County Sheriff Department for two new 2021 Ford Explorer Police interceptor utility vehicles, total \$75,032.00, paid out of 207-901-981.000 (patrol cars) and to outfit them by ProComm total \$37,983.00 paid out of 207-901-00-981-002 Vehicle Equipment.

Commissioner Martin made a motion to enter into an agreement with Assessing Solutions Inc. for Mentorship Services from July 1, 2021 to June 30, 2022 for a total of \$10,000.00 to be paid quarterly, and to authorize the Board Chair and the Equalization Director to sign all necessary documents; with a second from Commissioner Dermyer. Roll call vote: Todd-yes, Sanders-yes, Dermyer-yes, Arquette-yes, Martin-yes, Balulis-yes and Lodholtz-yes. Motion carried.

Commissioner Martin made a motion to approve the creation of a second part time Equalization Clerk position to be placed on Grade 2 of the MML wage scale, and to authorize the County Administrator to do budget amendments as needed; with a second from Commissioner Dermyer. Roll call vote: Dermyer-yes, Arquette-yes, Martin-yes, Balulis-yes, Todd-yes, Sanders-yes and Lodholtz-yes. Motion carried.

Commissioner Martin made a motion to approve that Diamond Lee to be hired in at the 2-year rate, effective 6/28/2021; with a second from Commissioner Balulis. Roll call vote: Martin-yes, Arquette-yes, Dermyer-yes, Sanders-yes, Todd-yes, Balulis-yes and Lodholtz-yes. Motion carried.
